# **Privacy Policy**

Your privacy is most important to us. At Verfio, we have adapted the privacy policy from Wordpress. We follow a few fundamental principles:

- We are thoughtful about the personal information we ask you to provide.
- We do not read, open or process any of your data except the list of files within the provided directory, their names, sizes and dates of last changes. The sole purpose is to provide you with the requested Verfio service.
- We store personal information for only as long as we have a reason to keep it.
- We aim for full transparency on how we gather, use, and share your personal information.

Below is our Privacy Policy, which incorporates and clarifies these principles.

## Who We Are and What This Policy Covers

Verfio.com is a "life saving" service that helps you check your most important backups, data and other services. We are also people behind Verfio, in a very small numbers, but trying our best to provide you with excellent service.

This Privacy Policy applies to information that we collect about you when you use our website Verfio.com.

Throughout this Privacy Policy we'll refer to services we provide on our website Verfio.com collectively as "Services."

## **Information We Collect**

We only collect information that we need for providing our Services, improving our Services or communication with you.

#### Information You Provide to Us

It's probably no surprise that we collect information that you provide to us. The amount and type of information depends on the context and how we use the information. Here are some examples:

- Email Address: We ask you to Sign up for an online account using your Email Address. All data sent from your browser to our server is via SSL protocol using modern cryptography, and the data is stored securely.
- Usernames and Passwords: In order to run Services, you need to provide us with specific usernames and passwords to external locations. Verfio does extensively encrypt both values so it is stored safely and protected from outside world.
- Payment Information: Paddle.com Market Limited ("Paddle") is a trusted payment gateway. Your payment details are securely transmitted directly to Paddle. Verfio does not read or store your payment details.

#### Information We Collect Automatically

We also collect some information automatically:

- Log Information: Like most online service providers, we collect information that web browsers, mobile devices, and servers typically make available, such as the browser type, IP address, unique device identifiers, language preference, referring site, the date and time of access, operating system, and mobile network information. We collect log information when you browse Verfio.com. We do not collect any log information when you are using the Chrome extension or Firefox Add-on.
- Information from Cookies & Other Technologies: A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Pixel tags (also called web beacons) are small blocks of code placed on websites and emails. Verfio.com uses cookies and other technologies like pixel tags to help us identify and track visitors, usage, and access preferences for our Services. Based on collected informations we are further improving our Services.

#### How And Why do We Use collected Information

#### Purposes for Using Information

We use provided and collected information for the purposes listed below:

- To provide our Services;
- To further develop and improve our Services-for example by adding new features that we think our users will enjoy or will help them with online marketing;

- To monitor and analyze trends and better understand how users interact with our Services, which helps us improve our Services and make them easier to use;
- To measure, gauge, and improve the effectiveness of our advertising;
- To monitor and prevent any problems with our Services, protect the security of our Services, detect and prevent illegal activities, fight spam, and protect the rights and property of Verfio.com and others, which may result in us declining the use of our Services;
- To communicate with you, for example through an email, about improvements, offers or promotions.

#### Legal Bases for Collecting and Using Information

A note here for users in the European Union about our legal grounds for processing information about you under EU data protection laws, which is that our use of your information is based on the grounds that:

(1) The use is necessary in order to fulfill our commitments to you under our Terms of Service or other agreements with you or is necessary to administer your account; or

(2) The use is necessary for compliance with a legal obligation; or

(3) The use is necessary in order to protect your vital interests or those of another person; or

(4) We have a legitimate interest in using your information–for example, to provide and update our Services, to improve our Services so that we can offer you an even better user experience, to safeguard our Services, to communicate with you, to measure, gauge, and improve the effectiveness of our advertising, and better understand user retention and attrition, to monitor and prevent any problems with our Services, and to personalize your experience; or

(5) You have given us your consent–for example before we place certain cookies on your device and access and analyze them later on.

#### **Sharing Information**

How We Share Information

We never share access, username, passwords or any other data from your private servers that you have shared with us.

We share information about you in the limited circumstances spelled out below and with appropriate safeguards on your privacy:

- Subsidiaries, Employees, and Independent Contractors: We may disclose information about you to our subsidiaries, our employees, and individuals who are our independent contractors that need to know the information in order to help us provide our Services or to process the information on our behalf. We require our subsidiaries, employees, and independent contractors to follow this Privacy Policy for personal information that we share with them.
- Business Transfers: In connection with any merger, sale of company assets, or acquisition of all or a portion of our business by another company, or in the unlikely event that verfio.com goes out of business or enters bankruptcy, user information would likely be one of the assets that is transferred or acquired by a third party. If any of these events were to happen, this Privacy Policy would continue to apply to your information and the party receiving your information may continue to use your information, but only consistent with this Privacy Policy.
- With Your Consent: We may share and disclose information with your consent or at your direction.
- Published Support Requests: And if you send us a request (for example, via a support email or one of our feedback mechanisms), we reserve the right to publish that request in order to help us clarify or respond to your request or to help us support other users.

# How Long We Keep Information

We generally discard information about you when we no longer need the information for the purposes for which we collect and use it—which are described in the section above on How and Why We Use Information—and we are not legally required to continue to keep it.

For example, we keep the web server logs that record information about visitors of Verfio.com, such as the visitor's IP address, browser type, and operating system, for approximately 30 days. We retain the logs for this period of time in order to, among other things, analyze traffic and investigate issues if something goes wrong.

## Security

We work very hard to protect your information against unauthorized access, use, alteration, or destruction. We are using the newest and most advanced methods and technologies.

# Choices

You have several choices available when it comes to information about you:

- Set Your Browser to Reject Cookies: At this time, Verfio.com does not respond to "do not track" signals across all of our Services. However, you can usually choose to set your browser to remove or reject browser cookies before using Verfio.com's websites, with the drawback that certain features of verfio.com's websites may not function properly without the aid of cookies.
- Close Your Account: While we'd be very sad to see you go, if you no longer want to use our Services, you can close your account. Please <u>email us for getting your</u> <u>account closed</u>. Please keep in mind that we may continue to retain your information after closing your account, as described in How Long We Keep Information above–for example, when that information is reasonably needed to comply with (or demonstrate our compliance with) legal obligations such as law enforcement requests, or reasonably needed for our legitimate business interests.

## Your Rights

If you are located in certain countries, including those that fall under the scope of the European General Data Protection Regulation (AKA the "GDPR"), data protection laws give you rights with respect to your personal data, subject to any exemptions provided by the law, including the rights to:

- Request access to your personal data;
- Request correction or deletion of your personal data;
- Object to our use and processing of your personal data;
- Request that we limit our use and processing of your personal data; and
- Request portability of your personal data.

You can usually access, correct, or delete your personal data using your account settings and tools that we offer, but if you aren't able to do that, or you would like to contact us about one of the other rights, scroll down to How to Reach Us to, well, find out how to reach us.

EU individuals also have the right to make a complaint to a government supervisory authority.
